General information

Julius Clinical B.V. complies with the requirements of the European General Data Protection Regulation (GDPR) and is responsible for all data processing on this website. In this privacy statement we outline how we process personal data collected through our website and how we use cookies:

In short:

- Julius Clinical does not collect, nor use personal data via the website.
- To analyze data on the use of our website, Julius Clinical collects anonymized data.
- Julius Clinical has taken appropriate security measures to protect data and to prevent unauthorized access to data. This also applies to the company hosting and administering this website.

Collection and Use of Personal Data

We collect anonymous data on the use of our website. These statistics help us to analyze the number of website visitors and to improve our products and services, including the user experience of our website. We do not collect personal data other than in the "Contact" section where you are asked to enter your personal data if you wish to contact us. Your data are then used to contact you and are stored for internal use only. Your data are not provided to or shared with third parties. The personal data you provide to us may be archived or stored periodically by us according to backup processes and will be retained for as long as is required for the purposes for which it was collected or to comply with legal or regulatory requirements.

Cookies

Our website makes use of cookies. Cookies are small files storing information for optimizing website use and analyzing visitor numbers. We only use non-privacy intrusive cookies improving internet experience and cookies counting the number of visitors to the website. None of the used cookies require user consent.

Google Analytics

We use Google Analytics to count visitors on our website and to get reports about website usage. We do not allow Google to use or share information obtained by Google Analytics for other Google services or other third parties. In addition, obtained IP addresses are anonymized by Google.

Our website may contain links to third-party websites. We are not responsible for how these third parties operate or treat your personal information, so we recommend that you read the privacy policies and terms associated with these third-party websites carefully.

Inspection and Modification of your Data
